Dear Dan:

It was a pleasure to meet with you again on December 21st. At that meeting you stated that you would send us the following information as soon as it was available:

- 1) the new CAD/CAM drawings of the rotary collider;
- 2) the results of the sieve analyses;
- 3) comparative data or any other information useful in assessing the performance of the collider as compared to prior art techniques, including if available, comparisons of particle size, size uniformity, speed, efficiency, and the ability of the collider to separate materials;
- 4) the issued patent in which you have an interest that relates to technology ancillary to the collider; and
- 5) samples of materials before and after being processed by the collider.

We are currently planning to report back to you by January 8th regarding our strategy with regard to new patent applications and patent strategy. The area of focus for new applications will be related to those areas that you noted as being of immediate significance, namely: recycling of electronic components, concrete, and clinkers, and processing of head ore, limestone and flint. We hope to be able to send to you for your review drafts of any new patent applications by the end of January.



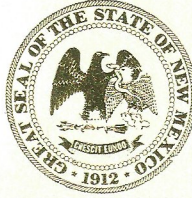


My dear brother Millard,

I just got back on Tuesday evening and I have been incredibly busy ever since getting ready for a Fuller Center board meeting this coming weekend. 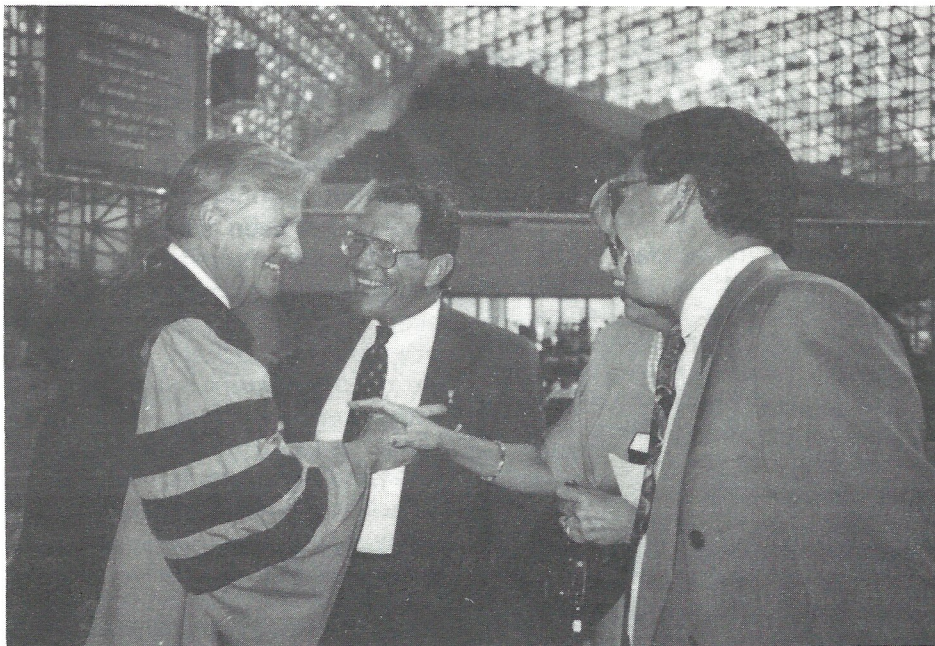
Thanks again for your good letter and phone call. I hope you and your wife are doing well these days. I send both of you warmest and best regards.


