On August 7<sup>th</sup> at the 50<sup>th</sup> Anniversary of The Southern Christian Leadership Conference, a historic partnership was initiated to raise the environmental awareness across America and achieve true **"Environmental Justice"** in Urban America.


Therefore, I also agree most strongly with my Colleague, Mayor Burns, that we join together and advance these "solutions" to the National Level.

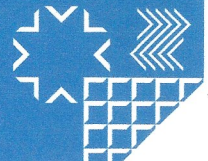
